

Disclosure consent and HBL-data protection matrix Coop Finance+ App

- I agree to the GTC and the following further contractual conditions of HBL. - I consent to HBL's release from bank client secrecy and data disclosure to Coop and third parties as well as abroad. 1) I hereby expressly release HBL (and its directors, officers, employees, agents and representatives) from all secrecy and confidentiality obligations under Swiss or other applicable law that might preclude the disclosure of such information (e.g. Art. 62 of the Swiss Federal Act on Data Protection or Art. 47 of the Swiss Federal Law on Banks and Savings Banks). 2) I agree that HBL will share certain personal data of mine for the use of the Coop Finance+ App of the Coop Cooperative (hereinafter "CF+ App" as well as "CF+ App Data") in accordance with the detailed specifications of the HBL-Data Protection Matrix with the recipients named therein (in particular Coop) for the purposes provided therein. The data disclosures are primarily made for the provision of the products and services requested by me within the scope of the CF+ App, but also for marketing purposes (e.g. for the use of the Coop Supercard). 3) I hereby instruct HBL and agree that HBL may also disclose my CF+ App data within the scope of the above-mentioned data disclosures to recipients who are domiciled abroad and/or who may store and process my CF+ App Data in systems that are located abroad. In this context, my personal data may be disclosed to countries with adequate data protection and to countries with non-adequate data protection. I acknowledge that data transferred abroad is no longer protected by Swiss law and foreign laws as well as official orders may require the disclosure of this data to authorities and other third parties.
